

(The First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

Clause 1

Clause 4

Validity

- 4.1 The agreement will be valid until it is terminated by either Party on mutually agreed terms. Just Engineering Technologies LLP, Pune, the Second Party will take effective steps to implement the MoU having coordination with the First Party.
